



# **PRIVACY POLICY**

## PRIVACY POLICY

This statement outlines the policy of Notesco UK Limited ("the Company" or "we" or "us") on how it manages the personal information it holds about its clients and others. This privacy applies to all website users, whether you are our former, existing or potential client or just a visitor of our website. We and our Cyprus based parent company, Notesco Financial Services Limited ("IronFX"), are data controllers for purposes of the data protection legislation.

Your privacy is of the utmost importance to everyone involved. To protect your privacy, we follow different principles in accordance with worldwide practices for client privacy and data protection.

- We won't sell or give away your name, mail address, phone number, email address or any other information to anyone, except as described in this policy.
- We will use various security measures to protect your information from unauthorised users.
- We will pass your personal information to IronFX. We may also pass your personal information to technology providers and/or social trading businesses.
- Any or all of these persons, bodies or entities may contact you with information about services which may be of interest to you, including by email, SMS, fax or automated calling systems: please tick the relevant box on our web page to confirm that you agree to this.

### Personal Information

Considering our nature of business and to perform our services offered to you efficiently, we will collect personal information.

### Notice

We will ask you when required for information that personally identifies you (personal information) or allows us and/or IronFX to contact you. Generally, this information is requested when you apply for a demo or a live account with us or IronFX as well as participating in any offer we and/or IronFX promote to our existing or potential clients as well as to any visitors on our websites. The main purposes we and/or IronFX use your personal information for is to introduce you to IronFX, to treat you fairly, and to understand your financial objectives and to ensure that relevant services are appropriate to your profile, as well as to provide you with sales and post sales services.

The personal information that will be collected from you includes:

- personal details you provide to us on applications and other forms,
- financial details such as estimated annual income and net worth and your trading experience and investment knowledge,
- documents that you provide to us to verify your identity, such as your passport, utility bills, and/or bank statement or your company incorporation details.

According to our regulatory regime we generally need to keep your personal information on record for a period of at least five (5) years, which is calculated after the execution of the transactions or the termination of the business relationship or in the case you wish to terminate your working relationship with us. Subject to that, when we consider information is no longer needed, we will remove any details that will identify you or we will securely destroy the records.

We and/or IronFX may use your personal information for one or more of the following purposes:

- to confirm your identity;
- to assess your suitability to the products and services IronFX provides;
- to process your transactions;
- to provide you with transaction and post transaction related services;
- to inform you of products and/or services that may be of interest to you;
- to keep you updated on the issues that are relevant to your business relationship with us and/or IronFX;
- to improve the Site;
- to analyse statistical data to enable us and/or IronFX to provide you with better products and/or services.

We and/or IronFX occasionally hire other companies to provide limited services on our behalf, including packaging, mailing and delivering purchases, sending postal mail, etc. We and/or IronFX will only provide those companies the information they need to deliver the service, and they are prohibited from using that information for any other purpose.

We and/or IronFX will disclose your personal information, without notice when required to do so by law or in good faith that such action is necessary to: (a) protect our and/or Iron FX's rights and/or comply with any court order or judicial proceedings; (b) avoid any potential fraud; (c) conform to the edicts of the law or comply with a legal process served on us, IronFX or the site; (d) protect and defend the rights or property of us, IronFX and its family of Websites, and, (e) act in urgent circumstances to protect the personal safety of users of us, IronFX, its Websites, or the public.

### **Cookies**

We and/or IronFX uses cookies to gather information about your access to our and/or Iron FX's website and other services we and/or IronFX provide to you. Cookies are small files of letters and numbers which use a unique identification tag and if you agree are stored on your device as a result of you using this website or other services we and/or IronFX provide to you. These cookies allow us to distinguish you from other users of our website, which helps us to provide you with a good experience when you browse our website and also allows us to improve our website.

Please click at the relevant point on our web page to confirm that you agree to our use of cookies on your device.

Most internet browsers are set up to accept cookies. If you do not wish to receive cookies, you may be able to change the settings of your browser to refuse all cookies or to have your computer notify you each time a cookie is sent to it, and thereby give yourself the choice whether to accept it or not. However, this may impair the quality of the services that we and/or IronFX provide to you in relation to your account.

### **Consent**

By visiting and/or accessing this website, you consent to us and/or IronFX to collect, maintain and use your personal information as per this policy.

### **Security**

We and IronFX have taken strong measures to protect the security of your personal information and to ensure that your choices for its intended use are honored. We and IronFX take strong precautions to protect your data from loss, misuse, unauthorised access or disclosure, alteration, or destruction.

We and IronFX strictly protect the security of your personal information and honor your choices for its intended use.

You also have a significant role in protecting your information. No one can see or edit your personal information without knowing your user name and password, so do not share these details with others.

In addition, we and IronFX, ensure the security of transmission of your payment card details that are protected using Transport Layer encryption-TLS 1.2 and application layer with algorithm AES and key length 256 bit in accordance with the recommendations of Payment Card Industry Security Standards Council.

### **Access**

Under the Data Protection Act you have the right to obtain a copy of any personal information which we hold about you and to advise us of any perceived inaccuracy. The Act sets out some exceptions to this. To make a request, please write to us, verifying your identity and specifying what information you require. We may charge a fee to cover the cost of verifying the application and locating, retrieving, reviewing and copying any material requested. We will acknowledge your request and respond to it within 40 days of receipt of your application and any applicable fee.

### **Enforcement**

We and/or IronFX reserve the right to change this policy anytime. Changes will be posted on this policy, therefore you are encouraged to visit and review this policy from time to time.
